Terms and Conditions

1. Equipment must be purchased and installed between October 1, 2024, and September 30, 2025.
2. Rebate application must be postmarked and submitted within 90 days of equipment purchase date on receipt, and be postmarked or submitted online by October 10, 2025. There is a maximum of two (2) ENERGY STAR® certified smart thermostat rebates per service address.
3. Applicant must be a residential electric customer of JEA.
4. It is the responsibility of the customer to assure that all requirements for the rebate are met. Failure to provide any of the required information will prevent processing of your application.
5. All rebated products must be used at the service (install) address specified on the rebate application. Customers must abide by the rules and rebate levels in effect on the date of purchase. Rebate levels cannot exceed the cost of equipment.
6. Purchase must be of a qualified high-efficiency ENERGY STAR certified smart thermostat.
7. All ENERGY STAR certified equipment must be listed at energystar.gov in order to participate in this program.
8. JEA and/or its designees, including program administrators and evaluation contractors, reserve the right to review installations to verify completion and measure energy savings to ensure compliance with all program requirements. Such reviews will be made at a time convenient to the applicant. Misrepresentation of installation location or measure eligibility may result in forfeiture of the rebate.
9. Program procedures, requirements and rebate levels are subject to change or cancellation without notice and are subject to available program funds.
10. Please allow 6–8 weeks from the date all required information is received to process your rebate(s).
11. You are urged to seek appropriate consultation concerning any tax liabilities that could be associated with the receipt of the rebate.
12. JEA and/or its designees, including program administrators, their parents, subsidiaries, affiliates, officers, employees, contractors and agents, assume no responsibility for the performance of the equipment or equipment warranty, the quality of the work, labor and/or materials supplied, and/or the acts or omissions of the participating contractor.
